

(ii) The Company has bought back 18,04,025 fully paid up equity shares of Rs. 2 each (in dematerialized form) from May 23, 2019 to August 31, 2019 and the same has been extinguished pursuant to Regulation 21 read with Regulation 11 of Buy Back Regulations:
